

SEVEN INTERNATIONAL CO-OPERATIVE PRINCIPLES

Sunrise Credit Union is guided by the principles of the international cooperative movement which values honesty, openness, social responsibility and caring for others. As a member of Sunrise Credit Union, you are part of a network of credit unions and other cooperatives across the world and can take pride in the principles by which co-operatives put their values into practice.

1st Principle: Voluntary and Open Membership

Co-operatives are voluntary organizations, open to all persons able to use their services and willing to accept the responsibilities of membership, without gender, social, racial, political or religious discrimination.

2nd Principle: Democratic Member Control

Co-operatives are democratic organizations controlled by their members, who actively participate in setting their policies and making decisions. Men and women serving as elected representatives are accountable to the membership. In primary co-operatives, members have equal voting rights (one member, one vote) and co-operatives at other levels are organized in a democratic manner.

3rd Principle: Member Economic Participation

Members contribute equitably to, and democratically control, the capital of their cooperatives. At least part of that capital is usually the common property of the cooperatives. They usually receive limited compensation, if any, on capital subscribed as a condition of membership. Members allocate surpluses for any or all of the following purposes: developing the co-operative, possibly by setting up reserves, part of which at least would be indivisible; benefiting members in proportion to their transactions with the co-operatives; and supporting other activities approved by the membership.

4th Principle: Autonomy and Independence

Co-operatives are autonomous, self-help organizations controlled by their members. If they enter into agreements with other organizations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control by their members and maintain their co-operative's autonomy.

5th Principle: Education, Training and Information

Co-operatives provide education and training for their members, elected representatives, managers and employees so they can contribute effectively to the development of their co-operatives. They inform the general public - particularly young people and opinion leaders - about the nature and benefits of co-operation.

6th Principle: Co-operation among Co-operatives

Co-operatives serve their members most effectively and strengthen the cooperative movement by working together through local, national, regional and international structures.

7th Principle: Concern for Community

While focusing on member needs, co-operatives work for the sustainable development of their communities through policies accepted by their members.

On behalf of the Board of Directors of Sunrise Credit Union, I'm pleased to present the 7th Annual Report relating to our operations for the year ended December 31st, 2014.

As in previous years, 2014 proved to be another very successful year for Sunrise Credit Union, and I'm pleased to be able to share some of the highlights with you.

We had good growth in 2014 despite the continuing low interest rates, as illustrated in the financial report that follows in the Annual Report. Growth was tempered however, as we are taking a more managed approach to growing our assets. This is due in part to regulatory change that governs credit unions in Manitoba and across the country. These changes are meant to provide security to our credit unions and our membership. We continue our goals of providing excellence in member service and ensuring that Sunrise is your financial institution of choice.

We were pleased to complete the merger with Sandy Lake Credit Union in 2014 and welcome them to our membership. We believe, as the saying goes, "we are stronger together". Another highlight has been the construction of our new premises in Brandon. The new building is progressing well as can be seen in pictures on our website. This new building will provide much needed space to house both branch and administrative services. It will also provide space to increase our wealth management services. We look forward to its opening in summer, 2015.

We welcomed a new Board Member in 2014, Fred Greig from Reston, and said goodbye to Glenn Caldwell, also from Reston.

Your Board has continued its education process in 2014. We participated in governance training and also took part in a facilitated board evaluation workshop. As well individual Members participated in individual training to enhance their skill set. Our Board committees were very active in 2014.

The Board of Directors create the Strategic Plan for the Credit Union, taking into consideration the vision, mission, values, long term goals, internal capabilities and the external operating environment.

The involvement of members in the Board of Director election process each year is important. Members elect Directors in a democratic one-member, one-vote system. They elect directors annually for a term that normally runs three years, up to a maximum of four consecutive terms.

In addition to attending regular Board meetings, each Director serves on a committee that assists the Board in its governance.

Directors' and Officers' Disclosure

Payments made for honouraria and per diems amounted to \$83,070 (2013 - \$68,749), reimbursement of expenses amounted to \$71,947 (2013 - \$32,030) and meeting, training and conferences costs amounted to \$31,313 (2013 - \$32,943) for the year ended December 31, 2014. Total loans and authorized lines of credits to directors amounted to \$2,324,752 (2013 - \$2,207,205), total deposits from directors amounted to \$1,716,189 (2013 - \$2,383,198)

PRESIDENT & CEO REPORT

Sunrise is a home grown financial institution whose roots are found in many small communities in Manitoba. We believe that we play a large part in making our communities better, stronger and more vibrant. In 2014 we welcomed the community of Sandy Lake to the Sunrise Family.

Regulation of the financial industry continues to expand which requires more resources from Sunrise in order to comply with additional regulations. In 2014 Sunrise engaged Internal Audit Services from Saskatchewan Credit Union Central. This arrangement will provide us with the expertise required to meet our needs regarding Internal Audit Services for the next few years.

New services and products continue to evolve in our industry. We will roll out a smart phone app and deposit anywhere technology in the 1st half of 2015. This technology will allow members to deposit cheques by taking a picture of the cheque and sending the picture electronically to the Credit Union. This technology will also provide an opportunity to become more efficient, as we focus on our goal of becoming paperless between branches. These will be major challenges for Sunrise going forward.

Sunrise will be moving into new premises at the corner of Victoria Avenue & 23rd Street in Brandon in early 2015. The Brandon Branch and Sunrise Wealth Management will occupy the main floor of this new building with the Corporate office occupying the 2nd floor. This will consolidate our operations into one location in Brandon. This new building will position us for many years of future growth in Brandon.


